1. Tender offers should be submitted in the prescribed Tender form available in website www.keralaagro.com along with required documents in sealed envelope addressed to Managing Director Kerala Agro Industries Corporation Ltd, Kissan Jyothi, Fort (PO), Thiruvananthapuram, 695023.
2. Bidders shall be remitted the cost of the Tender document and EMD by way of Demand Draft of any Nationalized bank obtained in favour of Managing Director, The Kerala Agro Industries Corporation Ltd and payable at Trivandrum.
3. Tender shall be accepted only if Demand Draft for Tender form and EMD is enclosed while submitting the Tender form.
4. Tenders without EMD/ cost of Tender form will be rejected.
5. Tenders should be submitted for Technical Bid and Price Bid in separate sealed covers clearly superscribing as "Technical Bid" and "Price Bid".
6. Technical Bid should contain the following,
 1. Duly signed and sealed Tender form, preliminary agreement executed in Kerala stamp paper worth Rs. 200/- in the prescribed Performa and duly signed and sealed declaration form.
 2. Copy of Test Certificates/ report issued from competent authority.
 3. Copy of catalogues and certifications like ISO.
 4. Duly filled Schedule A&B.
 5. Copy of address proof of the Registered Office of the Company & PAN & TIN details.

The other bid i.e “Price Bid” contains the rate quoted in the prescribed form. Scanned copy of detailed proposal containing AMC rate per year for the next three years after the expiry of the warranty (mention the number of breakdown and preventive maintenance visits) shall be submitted along with the “Price Bid”.

7. Forfeiture of EMD:- The EMD will be forfeited to Corporation in case after submitting the Tender, the Bidders withdraws his offer or fails to execute the agreement when called for to do so.
8. Cost of the Tender document is not refundable.
9. Tenders are to be submitted only by the manufacturers/ authorized dealers directly.
10. The rate quoted should be unit price and for the supply and installation of Packing machine having the prescribed specification and suitable for existing plant at Kerala Agro Fruit Products, Punalur.
11. AMC charge for three years after the expiry of the warranty period shall be quoted separately.
12. The successful Bidders will have to execute agreement in Kerala stamp paper worth Rs.200/- in the prescribed form and in the prescribed manner and furnish a security deposit of 5% of the total value of contract. Any exemption on payment of security deposit would be allowed based only on production of Exemption Certificate by the Government.
13. Security Deposit shall not bear any interest.
14. (a) Release of Security Deposit:- Security deposit unless forfeited to the Corporation in part or in full, will be refunded after the contract has been fulfilled and after meeting all the contractual obligations.
(b) The EMD of the Bidders who have not qualified in the bid will be refunded after finalizing the contract.
15. The period, terms and conditions of free service, warranty/guarantee and AMC offered by company should be specified . The supplier has to provide performance guarantee amounting to 5% value of the equipment supplied, by way of Bank Guarantee covering the period of warranty, subject to a minimum period of 12 months from the date of supply.
16. The Bidders should undertake to supply and install the equipment within three week from the date of placement of supply order.

17. 95% of the payment will be released after the successful installation of the equipment at Kerala Agro Fruit Products, Punalur and trial run of the equipment and balance 5% will be released after one month from the date of successful trial run and submission of performance guarantee. .
18. Submission of bills / invoices:- Bills addressed to Managing Director, The Kerala Agro Industries Corporation Ltd., "Kissan Jyothi", Fort, Thiruvananthapuram-695 023 is to be submitted in triplicate to the Consignee along with all documents, advance stamped receipt etc.
- 21 Refusal to accept the items supplied:- In case the materials supplied are of lower quality than the specified, the Corporation shall have the right to reject such materials. In such cases, the successful Bidders will have to remove the items immediately at their own expenses and materials conforming to the specification should be supplied afresh. Supply of lower quality items will also be entailed as sufficient reason to terminate the contract and blacklist the firm.
