1. Quotation offers should be submitted in the prescribed Quotation form available in website [www.keralaagro.com](http://www.keralaagro.com) along with required documents in sealed envelope addressed to Managing Director Kerala Agro Industries Corporation Ltd, Kissan Jyothi, Fort (PO), Thiruvananthapuram, 695023.
2. Bidders shall be remitted the cost of the Quotation document and EMD by way of Demand Draft of any Nationalized bank obtained in favour of Managing Director, The Kerala Agro Industries Corporation Ltd and payable at Trivandrum.
3. Quotation shall be accepted only if DD for Quotation form and EMD is enclosed while submitting the Quotation form.
4. Quotations without EMD/ cost of Quotation form will be rejected.
5. Quotations should contain the following,
  - 1 Copy of Test Certificates/ report issued from competent authority
  2. Copy of catalogues and certifications like ISO.
  3. Duly filled Schedule A&B.
  4. Copy of address proof of the Registered Office of the Company & PAN & TIN details.
5. Forfeiture of EMD:- The EMD will be forfeited to Corporation in case after submitting the Quotation, the Bidders withdraws his offer or fails to execute the agreement when called for to do so.

9. AMC charge for three years after the expiry of the warranty period shall be quoted separately.
- 10 The successful Bidders will have to execute agreement in Kerala stamp paper worth Rs.200/- in the prescribed form and in the prescribed manner and furnish a security deposit of 5% of the total value of contract. Any exemption on payment of security deposit would be allowed based only on production of Exemption Certificate by the Government.

The supplier has to provide performance guarantee amounting to 5% value of the equipment supplied, by way of Bank Guarantee covering the period of warranty, subject to a minimum period of 12 months from the date of supply.

within two week from the date of placement of supply order.

- 15 95% of the payment will be released after the successful installation of the equipment at our head office and after one week trial run of the equipment and balance 5% will be released after one month from the date of successful trial run and submission of performance guarantee.
- 16 Tenderer should have sales and service support in Kerala ( A self certified document in support of this must be included)
- 17 The bidder must not be blacklisted by any Government/Government agencies in India (A self certified document in support of this must be included)
